- Swimsuit or Lightweight Clothing (to wear underneath the divewear insulation -not cotton)
- A very small towel to dry your damp hair

- Regulator
- BC
- Tank (s) & Weights (plus a little extra if you have them)
- Mask, Snorkel & Open Heel Fins

All divers must fill out liability and rental forms for DUI prior to diving. If you would like complete the DUI Rental Form and Liability Release Form in advance, they are available at http://www.dui-online.com/demo-tour/demo-tour-forms/.

WHAT TO EXPECT

If you get a chance, check out the detailed information about the events at http://www.dui-online.com/demo-tour/what to-expect/. If that is not possible the information here will get you started.

When you arrive, check in at the registration table and present your certification card and driver's license or credit card. We'll fit your regulator with a drysuit hose then you will set up your tank, BC, regulator and weights so your dive equipment is ready to go. It is common for people to need a few extra pounds so bring it along if you have it. There is a rental and air station onsite as well as full service dive stores in town.

Then it's off to each station where the DUI Crew will fit you with ZipSeals, DiveWear Insulation, DUI Drysuit, RockBoots and more. We have DUI Weight & Trim Systems, Hoods, ZipGloves and even extra fins if yours don't fit.

At the water's edge, you will be assigned a dive guide who will show you the basics of how to use the drysuit and take you for a dive. You will stay above 40' and only do what you feel comfortable doing. After returning the equipment, have some lunch then do it again! The more dives you do in a drysuit, the more comfortable and confident you will be ... and the more fun you will have!

LOCATION & DIRECTIONS

Catalina Island has so much to offer. If you would like to learn more about what to expect diving at Catalina and Casino Point, check out this beautiful website for more details-http://www.uwphotographyguide.com/catalina-island-underwater. But first you have to get there. Ferries are easily available from several points: Dana Point, Newport Beach and Long Beach. You can check the schedules and learn more about the island by visiting the website www.visitcatalinaisland.com. We recommend you book your ferry reservations early and speak to the dive stores in the area if you need to reserve rental equipment. You may walk to the dive site from the ferry if you would like although we recommend you charter a cab to the dive site from the ferry dock as it is about a 1 mile walk or check your dive gear with the gear service near the docks to help move your gear for you to the dive site.
