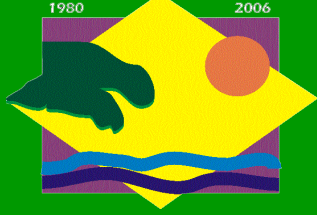

Bonaire is famous for its incredible macro-life. We've seen everything from huge schools of anchovies, turtles cruising by, Long-lure Frogfish, scorpion fish, splendid toads, octopus and more.

Buddy Dive is also known for its' casual atmosphere, personable staff, spacious accommodations and a dive operation that has it all: comfortable boats, complete rental and retail center, exceptional staff, and a unique "Drive Thru" with a two-lane air fill station.

Our trip includes an 8 Night Stay (Most are 7) plus 7 Days of a Single Morning Boat Dives and unlimited shore diving. All dive sites are well marked along the seaside road, and you simply pull over, gear up and walk in. The reef along this

side of the island lies less than 25 yards from shore in most places and provides a gentle drop along the shallow coral from about 35 feet

to a wide shelf at around 70 feet. The small island of Klein Bonaire (accessible by Boat) lies off the main island and offers excellent wall diving. Overall, Bonaire is low effort diving over some of the most beautiful soft coral and macro-life available!
