3 Tank Catalina Trip – Tanks Included

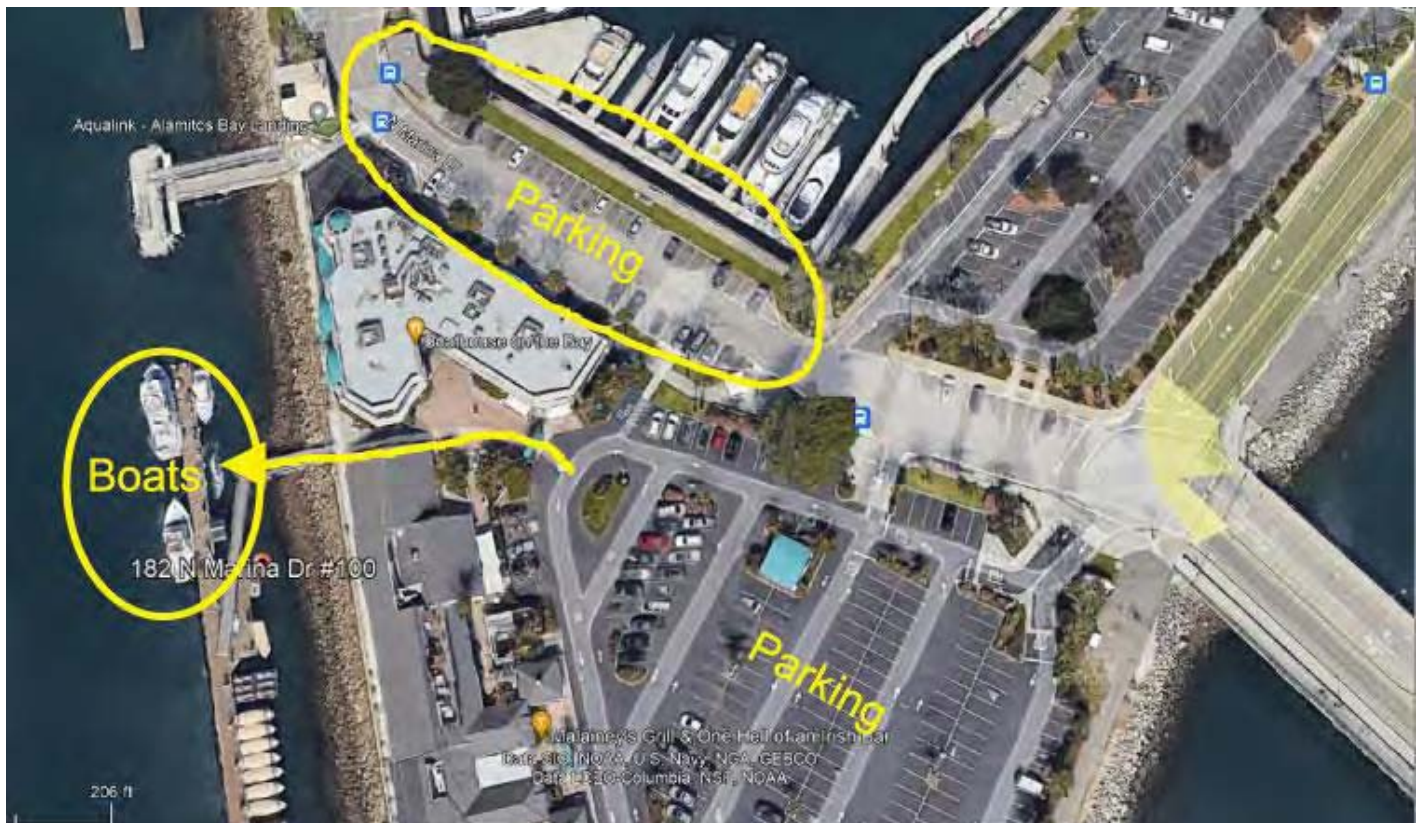
Your Sundiver Express 3 tank trip to the front side of Catalina includes:

- LP Steel 85s or AL 80s (some smaller steels too) and/or Express' compressor fills to 3000 psi for your personal tanks
- A light breakfast, snacks, beverages, lunch and dessert.
- They have some weights available for clients use as well – but they are limited.
- The Trip is approximately 7am-4pm dock to dock and normal boarding is 7am (be ready to board with all gear packed in a Dive Bag by 6:45 am).
- Their mappable address is:

 - o They state that the best place to park is on the stretch between the two big lots near Captain's Locker (Circled).

PLEASE – You MUST have your Gear Packed in a Bag:

1. Make sure you are on time (7:00 am Sharp or Earlier)
2. Pack your Gear in a Dive Bag (**Collapsible Bag**) that fits all your Gear except for BC & Weights (Wear those to the Boat & Carry your Bag with all other Gear).

PLAN ON TIPPING THE CREW – A fair Tip on Boats is \$5+ per Dive / \$20 min. (Bring Cash)

Sundiver Charters

- Location: 182 North Marina Drive, Long Beach CA 90803
 - The best place to park is on the stretch between the two big lots near Captain's Locker
- You will be Diving: CATALINA Island (Front Side)
- The Trip is approximately 7am-4pm dock to dock, and normal boarding is 6:45 am (please don't be late)

Trip Includes:

- LP Steel 85 or AL 80 Tanks (some smaller steels too) and/or Express' fills to 3000 psi for personal tanks.
- A light breakfast, snacks, beverages, lunch and dessert.
- They have some weights available for clients use as well – but they are limited. Best is to bring your own.
- Air Fills between Dives
- Divemaster's to help you on & off the Boat.

Notes to be prepared:

- **Please have a MESH Bag or a Collapsible Bag** to carry & Stow your dive gear when u get on the Boat. Hard Luggage or No Bag is unacceptable & rude to others (Note: Hard cases take too much space).
- **BE ON TIME TO THE BOAT!** You need to be on Board with all your Gear at 6:45 am. Following situating your gear, making sure you have EVERYTHING & Filling out RELEASES, the Boat will depart at 7am Sharp.
- **We DO NOT WAIT** for people who are late. Being on time is on you, so please plan accordingly.
- **Please come with about \$20 for the crew tip.** You will be catered to all day long. The Crew will fill your tanks after each dive & cater to you on & off the Boat. Boat etiquette is normally a MINIMUM of \$5 per dive tip - you will be making 3 dives & you are likely to need extra help. The crew works hard & you will be spoiled, so PLEASE tip accordingly.
- Pack your gear the night before. You should have your BC (With Weights), Tank & Regulator pre-assembled. Your Mesh bag should contain: Mask, snorkel, Fins, Boots, Gloves, Wetsuit, Defog, sunblock. When u park your car, put your BC on your back (Tank/weight/reg system), grab your mesh bag as well as your Dry Bag & walk to the Boat. It will be heavy & challenging, but u can do it! 😊 View the online map so u know where you're going.
- You can bring a separate dry bag with a towel, phone, sunblock, brush, Course Materials, Logbook, Tables etc. to keep with your gear as well.
- Expect GREAT things in Catalina. It's a world-class diving destination and you will see lots of cool stuff. Be prepared for some FUN!
- If you're not sure of the boat location. PLEASE look it up ahead of time & familiarize yourself with the area.

Take a deep breath & enjoy diving! You are blessed to have such awesome diving so close to home!
